**AMENDMENT TO H.R. 928, AS REPORTED  
OFFERED BY MRS. GILLIBRAND OF NEW YORK**

At the end of the bill add the following new section  
(and conform the table of contents):

1 **SEC. 9. INFORMATION ON WEBSITES OF OFFICES OF IN-**  
2 **SPECTORS GENERAL.**

3 (a) DEFINITION.—In this section, the term “agency”  
4 has the meaning provided the term “Federal agency”  
5 under section 11(5) of the Inspector General Act of 1978  
6 (5 U.S.C. App.).

7 (b) DIRECT LINKS TO INSPECTORS GENERAL OF-  
8 FICES.—

9 (1) IN GENERAL.—Each agency shall establish  
10 and maintain on the homepage of the website of that  
11 agency a direct link to the website of the Office of  
12 the Inspector General of that agency.

13 (2) ACCESSIBILITY.—The direct link under  
14 paragraph (1) shall be obvious and facilitate accessi-  
15 bility to the website of the Office of the Inspector  
16 General.

17 (c) REQUIREMENTS FOR INSPECTORS GENERAL  
18 WEBSITES.—

1 (1) POSTING OF REPORTS AND AUDITS.—The  
2 Inspector General of each agency shall—

3 (A) not later than 1 day after any report  
4 or audit (or portion of any report or audit) is  
5 made publicly available, post that report or  
6 audit (or portion of that report or audit) on the  
7 website of the Office of the Inspector General;  
8 and

9 (B) ensure that any posted report or audit  
10 (or portion of that report or audit) described  
11 under subparagraph (A)—

12 (i) is easily accessible from a direct  
13 link on the homepage of the website of the  
14 Office of the Inspector General;

15 (ii) includes a summary of the find-  
16 ings of the Inspector General; and

17 (iii) is in a format that—

18 (I) is searchable, sortable, and  
19 downloadable; and

20 (II) facilitates printing by indi-  
21 viduals of the public who are access-  
22 ing the website.

23 (2) OPTION TO RECEIVE RELATED INFORMA-  
24 TION.—The Inspector General of each agency shall

1 provide a service on the website of the Office of the  
2 Inspector General through which—

3 (A) an individual may elect to automati-  
4 cally receive information (including subsequent  
5 reports or audits) relating to any posted report  
6 or audit (or portion of that report or audit) de-  
7 scribed under paragraph (1)(A); and

8 (B) the Inspector General shall electroni-  
9 cally transmit the information or notice of the  
10 availability of the information to that individual  
11 without further request.

12 (3) REPORTING OF WASTE, FRAUD, AND  
13 ABUSE.—

14 (A) IN GENERAL.—The Inspector General  
15 of each agency shall establish and maintain a  
16 direct link on the homepage of the website of  
17 the Office of the Inspector General for individ-  
18 uals to report waste, fraud, and abuse.

19 (B) ANONYMITY.—The Inspector General  
20 of each agency shall take such actions as nec-  
21 essary to ensure the anonymity of any indi-  
22 vidual making a report under this paragraph.

23 (d) IMPLEMENTATION.—Not later than 180 days  
24 after the date of enactment of this Act, the head of each

1 agency and the Inspector General of each agency shall im-  
2 plement this section.
