22 **SEC. 201. DIRECT SPENDING.**

23 (a) MEANS-TESTED DIRECT SPENDING.—

24 (1) For means-tested direct spending, the aver-  
25 age rate of growth in the total level of outlays dur-

1       ing the 10-year period preceding fiscal year 2014 is  
2       6.7 percent.

3           (2) For means-tested direct spending, the esti-  
4       mated average rate of growth in the total level of  
5       outlays during the 11-year period beginning with fis-  
6       cal year 2013 is 6.3 percent under current law.

7           (3) The following reforms are proposed in this  
8       concurrent resolution for means-tested direct spend-  
9       ing:

10           (A) State budgets have suffered signifi-  
11       cantly during the economic downturn. Accord-  
12       ing to the National Governor's Association, half  
13       of all states are projecting lower total revenues  
14       in 2013 than they saw in 2008. To assist strug-  
15       gling states, the Back to Work Budget tempo-  
16       rarily increases funding for Medicaid – the sin-  
17       gle largest portion of total state spending –  
18       through the Federal Medical Assistance Per-  
19       centages program. This will help stabilize Med-  
20       icaid, which is a vital program for low-income  
21       and middle-class families, providing health and  
22       long-term care services to those stricken with  
23       catastrophic illness, injury, or disability, or fac-  
24       ing prolonged infirmity.

1 (B) The American Recovery and Reinvest-  
2 ment Act expanded a number of tax credits tar-  
3 geted at working families to boost relief during  
4 hard economic times. The Back to Work Budg-  
5 et retains the improvements made to the  
6 Earned Income Tax Credit (qualifying children  
7 and phase-out range), Child and Dependent  
8 Care Credit, and the American Opportunity  
9 Tax Credit. These credits fuel demand for  
10 American businesses by putting money in the  
11 hands of families that truly need it.

12 (b) NONMEANS-TESTED DIRECT SPENDING.—

13 (1) For nonmeans-tested direct spending, the

24 (A) Medicare is a cornerstone of the Amer-  
25 ican health care system for more than 45 mil-

1 lion America seniors. It is an exemplary pro-  
2 gram that provides the most efficient care to a  
3 segment of the population that costs more to  
4 treat. The Back to Work Budget protects bene-  
5 ficiaries and makes the system even more effi-  
6 cient. It amends Part D of Medicare to allow  
7 the Secretary of Health and Human Services to  
8 negotiate prescription drug prices with pharma-  
9 ceutical manufacturers, as the Department of  
10 Veterans Affairs currently does, which will save  
11 Medicare \$157 billion over 10 years and will re-  
12 duce costs for seniors. The budget adopts poli-  
13 cies to prohibit “pay for delay” agreements that  
14 reduce competition and modifies periods of ex-  
15 clusivity to increase availability of needed thera-  
16 pies. The budget also accelerates the use of  
17 bundling payments as an alternative to fee-for-  
18 service payments. It builds on Affordable Care  
19 Act efficiencies in administration of information  
20 and payments. Using standardized electronic  
21 systems for administration information such as  
22 claims, billing, payments and eligibility creates  
23 a more efficient and less fragmented health  
24 care system.

1           (B) The bulk of agriculture commodity  
2           subsidies go to large corporate farms that grow  
3           commodity crops such as corn, wheat, cotton,  
4           rice, and soybeans. These crops are often grown  
5           using unsustainable methods that require high  
6           levels of fertilizers, pesticides, and herbicides,  
7           leading to polluted waterways and degraded  
8           soil. The Back to Work Budget eliminates cer-  
9           tain commodity subsidies, which will save bil-  
10          lions, while reducing environmental impacts.
